The event will traditionally host Hip Hop and Disco Dance dancers. This year, dancers from rapidly developing dance styles such as Jazz Dance, Modern, Popping, Breaking, Salsa, Bachata, Caribbean Show, Performing Art Improvisation, and Show Dance will also be able to showcase their skills according to the event's formula.

The Championships will once again take place under the auspices of IDO and PZTan. This time, we will host the event at Arche Cukrownia Żnin - the venue where the IDO European Championships in Hip Hop took place in 2024. On behalf of the organizers, we warmly invite you to the hospitable Żnin.

### **Competition rules:**

The tournament will be held in accordance with the rules of IDO and the Polish Dance Union.

### **Goals of the Championships:**

- The main goal of OMP 2025 is to popularize and promote the development of modern dance as an alternative form of spending time among children, youth, and adults.
- Popularization of dance as a form of active recreation.
- The search for new styles and directions in the development of modern dance.
- The opportunity to achieve higher rankings in each age category.
- Promotion of Arche facilities.

### **The judging panel approved by the Board of the Polish Dance Union includes:**

- A non-scoring Head Judge and scoring judges of the Polish Dance Union, as well as international judges – a minimum of 3 and a maximum of 7 members.
- A Scrutineers' committee,

The Skating System will be used to calculate final results in Open categories, and the Extra League/Open. Teams in the 1st League will be ranked in 1st, 2nd, and 3rd place.

Please note:

- We do not accept individual donations – the club makes the payment.
- Registration is handled by a club representative.
- Individual registration is not possible.
- The coach/club representative (supporting member) is responsible for incorrect registration.
- In the event of a justified protest, incorrectly registered participants will be disqualified from the relevant category and dance discipline. In this case, all fees (including entry fees) are non-refundable.

### **Booking accommodation and meals.**

The organizers do not provide accommodation or meals. Information on accommodation and meal options will be published in a separate announcement by November 15, 2025.

### **Final information:**

- The organizer is not responsible for valuables left in the locker room.
- Competitors' insurance is provided by the registering institutions.
- The organizer does not provide supervision for the competition participants.
- All dancers are required to wear athletic shoes.
- Shoes that may damage or scratch the dance floor are not permitted.
- Own music must be in MP3 format on a pen drive.
- Own music must be delivered to the DJ no later than 20 minutes before the start of the competition.
- Written consent from the organizer is required for any advertising.
- Fire safety regulations and safety rules in force in the hall must be observed.
- Entry to the dancers' zone is permitted only with the participant's, coach's, or guardian's ID.
- In the event of damage, the participant responsible for the damage is responsible for covering the cost of repair.
- Registration and participation in the XXIX OMP (International Open Poland) Żnin'2025 is tantamount to expressing permanent and unconditional free consent to photographic, internet, video and television recording of all presentations and their use, publication and broadcast in any media by the organizers, as well as to the use of personal data in materials from the Championships.
- The official club representative/coach of a given club has the right to withdraw dancers from participation in the XXIX OMP (International Open Poland) Żnin'2025 at any stage. Withdrawals must be in writing. After the application deadline – i.e., from December 2, 2025 – and in the event of failure to qualify for subsequent rounds, the entry fee is non-refundable.
- Protests, submitted in writing only, will be accepted up to 30 minutes after the end of a given competition, upon payment of a deposit of PLN 200 (refundable if the protest is found to be justified; forfeited if the protest is not recognized). The deposit will be considered by the Chief Judge with the participation of the organizer and a representative of each organization.
- There will be a medical emergency point next to the dance floor.
- Law enforcement will be on duty at the venue.
- Ticket prices: One day: PLN 50 for adults / PLN 20 for retirees / children 2018 and younger – free of charge, with discounts only, valid ID required. Ticket purchase also entitles you to free amateur filming and photography from the stands.

# Qualification Rules and Procedure for the Grand Finale

## Solos and duos.

Competitors in the junior and adult categories who earn the highest points in the solo open/duet open categories advance to the semifinals. Finalists are then selected from the semifinals and receive cash prizes.

In the case of multiple performances in which a competitor dances, the performance with the highest score will be considered.

## Teams (Adults and Juniors).

The eight teams with the highest points will advance to the Grand Finale. In the final competition, teams will compete for cash prizes awarded to the first, second, and third place winners.

## Teams (Children's Category).

In the children's category, the three teams with the highest points will be selected to compete for 1st, 2nd, and 3rd place during the finals as the best children's teams (no cash prizes). Each team will receive a commemorative trophy.

**The Grand Finale will be judged by at least nine judges.**

## **GDPR – personal data:**

1. The controller of personal data collected and processed during the implementation of the XXIX OMP (International Open Poland) Żnin'2025 is the Polish Dance Association with its registered office in Wrocław, 50-228 Wrocław, ul. Siemieńskiego 17/5; Tax Identification Number (NIP): 8951829742, National Business Registry Number (REGON): 020034041.
2. Personal data will be processed for the purposes of implementing the XXIX OMP (International Open Poland) Żnin'2025. Providing personal data is voluntary. To participate in the event, providing data is necessary for organizational reasons – inclusion on start lists, diplomas, event results, settlement of payments, preparation of the framework program, etc. The legal basis for the processing of personal data is their necessity to fulfill the obligation to implement the tournaments – (Article 6 paragraph 1 letter c) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016). on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC, in force from 25 May 2018 (hereinafter referred to as "GDPR").
3. The personal data provided will be processed for the duration of the competition and the period of pursuing any claims, as well as the period for settling public law settlements based on applicable regulations and for archival purposes – competition results.
4. For the purposes of preparing and implementing the competition, the Controller may entrust the processing of personal data to entities cooperating with them in the field of technical, promotional, and organizational support.
5. Individuals who have provided their personal data have the right to:
  - access their personal data and have it corrected or rectified,
  - request the deletion of personal data from the Controller's files or restrict its processing, if the data does not prevent the Controller from fulfilling the obligation to conduct the competition – (Article 6, paragraph 1, letter c) of the GDPR).
